PRIVACY AND PERSONAL DATA PROTECTION POLICY



World Quest LLC (registration number 42934578), located at Naberezhnaya Street, Building 23A, office 328, Kyiv, 02000, Ukraine (referred to as "World Quest") collects personal information when you register to use our platform ("Platform"), access World Quest websites, mobile applications, or any other services we provide, or contact us online (collectively referred to as "Services"). By utilizing these Services, you consent to the terms outlined in this Privacy Policy. If you do not agree with this Privacy Policy, please refrain from using the Services. We reserve the right to modify this Privacy Policy, so we encourage you to periodically review it to stay informed about any changes. Continued use of the Services after any modifications to the Privacy Policy will indicate your acceptance of those changes.

This Privacy Policy outlines how we collect, use, disclose, and/ or process personal information that you provide or that we gather through our websites and mobile applications. We will handle your personal information in compliance with the applicable local laws and regulations, including but not limited to the Law of Ukraine on Personal Data Protection (2010).

This Privacy Policy is applicable solely to the Services where it is made available by World Quest and does not extend to websites, networks, or platforms maintained by third-party companies or organizations to which we may provide links. Please be aware that when you access any third-party websites, networks, or platforms via links provided within our Services, World Quest is not responsible or liable for the content or activities of those third-party entities and their privacy policies. Additionally, World Quest does not guarantee the security of any personal information shared or collected by those third-party services. WHEN DOES COLLECTION TAKE PLACE

(B) We will collect, use, disclose, and/or process personal information only to the extent that it is reasonably necessary to fulfill your requests or for purposes we have previously communicated to you.

(c) If you choose not to provide personal information when requested by World Quest, this may limit our ability to deliver our Services to you, which includes, but is not limited to, processing your account creation, registration for contests or promotions, or addressing your customer service and technical support requests.

(D) You have the right to withdraw your consent at any time. However, please note that withdrawing your consent may lead to the closure of your World Quest Account and/ or the cessation of Services provided to you.

TYPES OF PERSONAL INFORMATION COLLECTED

We collect the following categories of personal information:

- **Registration Information:** Details provided when creating an Account, including your first and last name, country of residence, gender, date of birth, email address, username, and password.
- **Transaction Information:** Information you provide when requesting details or using our Services through our websites or mobile applications, such as your postal address, telephone number, and payment information.
- **Public Forum Information:** Data you share in public forums on our Platform, websites, and applications.
- **Messaging Information:** Information exchanged either one-on-one or within a limited group through our messaging, chat, post, or similar features, where we are legally permitted to collect, use, disclose, and/or process this information.

Location Information

We may collect location data when you visit our websites or use our applications. This includes location information provided by a mobile device interacting with our websites or applications (including through beacon technologies) or associated with your IP address, where we are legally permitted to collect, use, disclose, and/or process this information.

Additionally, we gather usage, viewing, and technical data, including your device identifier or IP address, when you visit our websites, use our applications on third-party platforms, or open emails we send.

Please be aware that we may be required by local law to take steps to ensure that you have authorized the relevant third party to share your personal information with us.

PURPOSES FOR COLLECTION, USE, DISCLOSURE, AND PROCESSING OF YOUR PERSONAL INFORMATION BY WORLD QUEST

The personal information we collect from you may be used, disclosed, and/or processed for various purposes depending on the circumstances surrounding the processing of your data, including but not limited to:
